This Agreement sets forth the terms of the license from IDEXX Laboratories, Inc. for xChek\* Lab software applications provided to you by IDEXX, its affiliates or our authorized distributors. The words we, us and our refer to IDEXX, IDEXX's affiliates and our authorized distributors. BY USING THE xChek Lab SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT EVEN WITHOUT YOUR SIGNATURE. IF YOU DO NOT ACCEPT THESE TERMS AND CONDITIONS, DO NOT USE THE xChek\* Lab SOFTWARE, AND RETURN IT TO US WITHIN THIRTY (30) DAYS, AND YOU MAY OBTAIN A REFUND OF THE AMOUNT YOU ORIGINALLY PAID FOR IT. This Agreement may be updated by IDEXX from time to time without notice to you. You may review the most current version of the Agreement at any Terms posted on the IDEXX General and Conditions page https://www.idexx.com/en/about-idexx/terms-of-sale/.

- 1. DEFINITIONS: As used in this agreement, the following terms, whether used in the singular or plural, shall have the following meanings:
- 1.1 "Software Product(s)" means the xChek Lab computer program(s) consisting of a series of instructions or statements in machine readable, object code form only; any fixes, revisions, updates, upgrades, enhancement or other modifications to the foregoing; and any related user guide and other printed, written, "online" or electronic documentation and materials.
- 1.2 "Use" means copying all or any portion of the Software Products from storage units or media for the purpose of processing the instructions or statements contained in the Software Products.
- 2. LICENSE: Subject to the terms and conditions set forth in this agreement, we grant to you, and you accept, a non-exclusive, non-transferable license, without the right to sublicense, to Use the Software Products for your internal purposes only. Without limiting the foregoing, we do not grant any rights for the Use or other utilization of the Software Products, directly or indirectly, for the benefit of any person or entity except you, or for the purpose of developing application programs, written materials or other products.
- 3. OWNERSHIP, INTELLECTUAL PROPERTY RIGHTS AND OTHER RESTRICTIONS:
- 3.1 We (which for the purposes of this agreement includes any person who licenses all or any portion of the Software Products to us) retain all right, title and interest in the Software Products and any copies thereof, including all copyright, trade secret, patent and other intellectual or industrial property rights therein. Physical copies of the Software Products (in any media, which we provide you or which you use to make copies of Software Products provided to you electronically, such as via the Internet or otherwise) remain our property, and such copies shall be deemed to be on loan to you during the term of the license granted by this agreement.
- 3.2 We disclose the Software Products to you in confidence, and you shall not cause or permit disclosure, copying, display, loan, publication, transfer of possession (whether by sale, exchange, gift, operation of law or otherwise) or other dissemination of Software Products, in whole or in part, to any third party

without our prior written consent. You shall limit use of and access to the Software Products to such of your employees as are directly involved in their utilization. You shall take all reasonable steps to safeguard the Software Products and to ensure that no unauthorized persons have access to them and that no persons authorized to have such access take any action that would be in violation of this agreement if you took such action yourself. You shall promptly report to us any actual or suspected violation of this subsection and shall take further steps as we may request to prevent or remedy any such violation.

- 3.3 You shall not alter or remove any copyright, trade secret, patent, proprietary and/or other legal notices contained on or in copies of the Software Products. The existence of any such copyright notice on Software Products shall not be construed as an admission, or be deemed to create a presumption, that publication of such materials has occurred.
- 3.4 You agree not to use the Software Products for the benefit of any other person (including on a time-sharing, service bureau or other basis), or for developing application programs, written materials or other products. You agree not to modify, enhance, reverse engineer, decompile, disassemble, or otherwise change or supplement the Software Products.
- 4. UPDATES: Except as may be set forth in our limited warranty, you have no rights to future software patches, fixes, revisions, updates, upgrades, enhancements or other modifications (collectively, "modifications"). If we provide you any modifications, it is strictly an accommodation to you; and you agree such accommodation gives you no basis to claim you have a right to such modifications. Upon receipt of updated or revised Software Products, you agree to promptly return to us the disks or other media containing the previous release of the Software Products.
- 5. LIMITED WARRANTY: We warrant that the Software Products will perform in accordance with specifications published by us for a period of 90 days from the date of delivery of such Software Products to you. Our sole obligation with respect to claims of non-performance made by you within such 90 day period shall be to take commercially reasonable steps to remedy the non-performance by replacement of the Software Products. This warranty shall not be applicable in the event that replacement is ineffective due to your hardware or other software.

- 8.3 Because unauthorized use or transfer of the Software Products may substantially diminish the value of such materials and irrevocably harm us, if you breach the provisions of Section 3 of this agreement, we shall be entitled to injunctive and/or other equitable relief, in addition to other remedies afforded by law, to prevent a breach of such Section.
